## Labor Shed Analysis

A labor shed analysis is defined as where workers work and where workers live relative to a user-defined selection area. This analysis helps to determine where a labor market draws its commuting workers. Labor shed studies can draw comparisons between various geographies including state, Congressional District, Metropolitan Statistical Area (MSA), county, Workforce Investment Area (WIA), Zip Code, and Census tract. By indicating how many of the selection area workers work outside the area, labor sheds can help identify potential pools of workers who would be available for work in the user-defined area.

Labor shed studies provide economic developers and existing or prospective employers a tool to understand the local labor market and make informed expansion and site selection decisions. In addition, labor shed studies can help indicate potential impacts from environmental, social, or economic incidents.

## OnTheMap, Census Bureau

OnTheMap is a mapping and reporting tool developed by the U.S. Census Bureau showing employment and home locations of workers with companion reports for user-defined areas. It is the first synthetic data product released by the Census Bureau. OnTheMap is an important tool for Florida to perform labor inflow/outflow analyses and provide commuting data to planning and economic development agencies as well as Regional Workforce Boards. OnTheMap data is also used by the Department of Economic Opportunity to help quantify natural disaster impacts for emergency management agencies based on where workers live and where they work.

OnTheMap integrates existing data from state-supplied administrative records on workers and employers with existing federal censuses, surveys, and other administrative records. The state Labor Market Information (LMI) agencies supply key data from unemployment wage records and from businesses each quarter. The Census Bureau merges the state-supplied data with current demographic information to produce the data found in OnTheMap. By combining data from different administrative sources, censuses, and surveys, the Census Bureau produces local employment information that was not previously available.

## Florida Department of Economic Opportunity, Bureau of Workforce Statistics and Economic Research (WSER)

The Florida Department of Economic Opportunity, Bureau of Workforce Statistics and Economic Research (WSER), produces, analyzes, and distributes labor statistics to improve economic decision making. These data are produced as part of the federal/state cooperative statistical program with the U.S. Department of Labor, Bureau of Labor Statistics, and the Employment and Training Administration.

## Executive Summary

The analysis of workforce and demographic characteristics, including commuting patterns of Pinellas County was conducted to provide economic data on the population and labor force living or working in the county. The report is useful for detailing where workers work and live in order to align resources. This report includes population, labor force, and demographics for Pinellas County.

Workers employed in Pinellas County are clustered in the Health Care and Social Assistance (16.1\%), and Retail Trade (11.6\%) industries. Workers living in Pinellas County are concentrated in the Health Care and Social Assistance (15.1\%), and Retail Trade (11.6\%) industries.

A detailed examination of commuting patterns for Pinellas County shows that the county has a net inflow of 30,298 workers. Using the latest annual Census data available, there were 434,780 workers employed in Pinellas County and 404,482 workers living in Pinellas County. Of the workers who lived in the county, 142,159 workers (35.1\%) were employed outside the county.

With $35.1 \%$ of workers who reside in Pinellas County employed outside the county, Pinellas County was ranked 58 of 67 for the highest outflow rankings among Florida counties. Leon County (20.7\%) had the highest outflow rate, followed by Miami-Dade County (21.4\%) and Duval County (24.9\%). Glades County (84.2\%), Jefferson County (81.7\%), and Gilchrist County (80.0\%) had the lowest worker outflow rates.

Of the 142,159 Pinellas County workers employed outside the county, the top destination counties are Hillsborough County ( 64,125 workers), Orange County ( 10,331 workers), and Pasco County ( 9,366 workers). Of the 172,457 Pinellas County workers living outside the county, the top origin counties are Hillsborough County ( 60,128 workers), Pasco County ( 31,725 workers), and Manatee County (10,527 workers).

Of the 434,780 people who are employed in Pinellas County, 262,323 (60.3\%) live and work in the county. There are 172,457 (39.7\%) workers who live outside Pinellas County and work within the county. Of the 404,482 workers who live within Pinellas County, 142,159 (35.1\%) residents work outside the county. There is a net inflow of 30,298 workers into Pinellas County.
