### **PRIME REDEVELOPMENT & OPERATIONS PROJECTS**

#### **EMPLOYMENT SITES PROGRAM**

Pinellas County's Employment Sites Program (ESP) continued to support the construction and redevelopment of industrial and office buildings to provide growth opportunities for existing businesses and attract new target industry employers to Pinellas County. The Starkey Lakes North, Wendover Art Group, and Lockheed Martin ESP projects were completed in FY2023, and eleven Funding Agreements from Rounds Two, Three, Four were executed for a total \$19M+ investment and the construction or renovation of more than 296,000 square feet of space. Our team was honored to receive the Future of the Region Economy & Energy Award from the Tampa Bay Regional Planning Council, recognizing the ESP, and the Urban Deal of the Year Award from the Florida Economic Development Council, recognizing Brooker Creek South, an ESP project.

#### **ARK INNOVATION CENTER**

The Pinellas County Commission on December 18 held a ribbon cutting ceremony celebrating the completion of the ARK Innovation Center, a new 45,000-square-foot business incubator located at 1101 4th St S. in St. Petersburg. Pinellas County in partnership with the U.S. Economic Development Administration, the City of St. Petersburg, the Tampa Bay Innovation Center, and ARK Invest, designed, constructed, and equipped the new facility. ARK Invest's collaboration with the new incubator will allow the Tampa Bay Innovation Center to focus on growing early-stage companies that are advancing disruptive technologies in the areas of Internet of Things (IoT), Energy, FinTech, Artificial Intelligence, and Blockchain.

### **BUSINESS RETENTION & ATTRACTION**

PCED's Business Development team had an exceptionally busy year responding to leads from businesses considering a relocation to Pinellas, connecting with existing Pinellas companies to ascertain current and upcoming needs for expansion, and working with our local municipalities and chambers of commerce to strengthen the partnerships that support local business prosperity. Showcasing the efforts of our team and the appeal of Pinellas County's thriving aviation and defense industries, high-tech aviation company Chromalloy/Belac worked with PCED to expand its operations, utilizing the benefits of the Employment Sites Program.

### **OFFICE OF SMALL BUSINESS & SUPPLIER DIVERSITY**

The Office of Small Business & Supplier Diversity (OSBSD) at PCED reached new levels of contribution to local economic growth and community vitality through its outreach via the Florida Small Business Development Center (FSBDC) and Small Business Enterprise (SBE) programs. The OSBSD team collectively surpassed its goal of supporting new business start-ups by 62%, and contract awards to valued SBE vendors hit a remarkable high of more than \$38.5 million. The division developed a partnership with Amazon Business to aid local small businesses in reaching greater sales opportunities, and partnered with the City of St Petersburg in administering its new CRA Micro Fund Program.
